and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 2) Color TV - 02 nos
- 3) Tubelight - 02 nos
- 4) CFL - 04 nos
- 5) Electric Bulb - 03 nos

Out of which I seized the following.

- 1) Pvc 2 Core service connection cable with Bypass arrangement - 5ft (approx)
- 2) Bulb with Holder - 01 nos

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 02:50 pm on 17/01/18. The accused person has committed an offence U/S135(I) (a) of the electricity act.-2003 subsequently electricity (Amendment) act.- 2007.
