Sub:- Intimation regarding theft of two no's of Alum Solution Tank Agitators standby Motors from Old Raw Water Pump House inside STPS plant on 12.01.2018.

Sir.

In enclosing copy of the letter received from Sri Samir Baran Maiti, Sr. Manager (Operation) STPS. WBPDC. Santaldih on 13.01.2018 to the effect that on 12.01.2018 at about 23.00 hrs the shift charge Engineer on duty informed him that during normal checking by the operator posted at Old raw water pump house, they detected that two no's of Alum solution tank agitators standby Motors. Specification of motors as follows:- Make:- Crompton Greaves, Rating : 0.55 KW, Amps-1.9Y, Frame-D90L, Voltage-415V. Speed- 680RPM were missing which were available in previous shift. During physical checking by the concern Engineer in presence of security personnel posted at old raw water pump house, STPS, found that some unknown miscreants committed theft in respect of above two motors by removing from the base bolts. Base bolts and live power cables of the said motors were lying at the place of occurrence.

Under the above noted circumstances you are requested to lodge an FIR and necessary action may be taken from your end at the earliest.
