On 20.01.18 he came to the office at around 08.15 hrs and found that one DELL make 14" laptop was missing from his table and power cable adaptor, mouse & LAN connection cable were found opened and lying on the table. The exact specification of the laptop is not known at this moment but the vital official documents & data including the "smart grid" & "secure" meter reading software were installed in that laptop.

Under these circumstances you are requested to lodge an FIR and necessary action may be taken from your end at the earliest.
