Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **SUNIL HAZRA**, S/O- MOTILAL HAZRA of Village-Gahira, P.S.-PARA, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 17.01.2018 at about 11.00AM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with Mr. Avishek Das, SAE(E),Dubra Para CCC,Mr. Manmatho Mahali, Sr.TSH,Dubra Para CCC inspected the premises of SUNIL HAZRA, S/O- LATE MOTILAL HAZRA of Village- Gahira, P.S.-~~Para~~, Dist Purulia WBSEDCL. During inspection and it was found that the said **SUNIL HAZRA** was enjoying electricity unauthorizedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 01 nos Ceiling fan, 01 no TV and 05 nos bulb, approx load 0.560 KW for domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 11.15AM.

As such **SUNIL HAZRA** S/O- Late MOTILAL HAZRA of Village-Gahira, P.S.-~~Para~~, Dist-Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
