Entered the premises of Kuxan Boni, S/o - Lt. Monda Boni, Vill. Balitora, P.S. Santuri, Dist- Purulia, having Consumer No 201836080, Meter No. L4429629 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Bulb - 0.2 hrs
- 2) Color TV - 01 no
- 3) Electric Fan - 0.1 hrs

Out of which I seized the following.

- 1) Tapping portion of PVC 2 core Incoming Service Connection Cable - 2.5 ft (APPROX).
- 2) Electric Bulb 01 no with Holder

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 3:25 PM on 19/01/18. The accused person has committed an offence U/S135(1)(b) of the electricity act - 2003 subsequently electricity (Amendment) act - 2007.
