Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Gulab Chand Shankar (present user) was enjoying electricity unauthorizably i.e. bypassing of meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/s 135(b) of the electricity (Amendment) act- 2007 on 13/02/18 at 15:00pm

Entered the premises of Gulab Chand Shankar VIII Lower Bariaspali / Arabinde Pally P.S. Adra Dist. Purulia, having Consumer No. 200888358. Meter No. HR098904 and inspected his premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Electric Heater - 01 no
- 2) CFL - 04 nos
- 3) Electric pump - 01 no.
- 4) Fridge - 01 no
- 5) Electric Fan - 04 nos
- 6) Color Tv - 01 no.

Out of which I seized the following

- 1) Electric Heater alongwith connecting wire - 01 no.
- 2) 2x1 Core PVC cable alongwith bypassing arrangement - 3ft (approx).

Seizure list was prepared at the site and accused person refuse to sign/signature. The inspection team left the premises at 5:10 PM on 13/02/18. The accused person has committed an offence U/S 135(1)(b) of the electricity act - 2003 subsequently electricity (Amendment) act - 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
