In producing here with one arrested accused person namely Paresh Mudi (41 Yrs) S/O Lt. Lt. Mahadeb Mudi of Vill- Gopinathpur (Mudi Para) PS- Adra Dist- Purulia along with following seized articles viz-

- 1) 18 bottles (in sealed condition) DILSE 80 up country spirit, 600-ml each bottle and value-Rs-35 of each bottle.
- 2) Sale proceed of Rs.-60/-
- 3) Ten pieces of plastic glass.

I SI Supratik Mondal of Adra P.S. do here by lodged a complaint against accused namely Paresh Mudi (41 Yrs) S/O Lt. Lt. Mahadeb Mudi of Vill- Gopinathpur (Mudi Para) PS- Adra Dist- Purulia to the effect that on 11.02.18 at about 17:35 hrs. in course of my anti crime evening mobile duty I received a telephonic information from a reliable source that one namely Paresh Mudi (41 Yrs) S/O Lt. Lt. Mahadeb Mudi of Vill- Gopinathpur (Mudi Para) PS- Adra Dist- Purulia was stocked country spirit illegally and selling the same to hike price for his personal gain then I informed O/C Adra PS and as per order of O/C Adra PS myself along with JC/ 342 Kashinath Chakraborty & NVF/365 Ambuj Mahato rushed to the spot for raid by Govt. vehicle. At about 18:15 hrs. myself along with force reached at Gopinathpur village and hold raid in the Pan Stall of Paresh Mudi (Gopinathpur, Mudi Para) and found that said Paresh Mudi sealing liquor at his own Pan Stall and seeing the Police party some person fled away and said Paresh Mudi to concealed himself but we are able to apprehend him and also detained him. I asked him to produced valid License or valid papers of selling country spirit but he failed to produced any valid license or documents for possessing /selling the same, So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accused person and available witnesses.

Hence I there for pray that a specific case may kindly be started against arrested accused Paresh Mudi (41 Yrs) S/O Lt. Lt. Mahadeb Mudi of Vill- Gopinathpur (Mudi Para) PS- Adra Dist- Purulia and arrange for its investigation.
