LT OH line with the help of p.v.e wire which indicates use of electricity dishonestly. As the theft of electricity was detected during inspection by hooking method and using electrical equipment like bulbs, T.V. etc. we disconnected the unauthorised electric line and seized the seizure article in proper seizure list - as token basis. The local people refused to put signature in the seizure list. After completion the inspection we left the spot at about 1.40 P.M.
