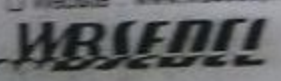

L.T.O.H line with the help of single core ch-wire which indicates use of electricity dishonestly. As the theft of electricity was detected during inspection by hooking method and operating paddy extracting machine. We disconnected the unauthorised electric line and seized the seizure article in proper.

Seizure list as taken basis, the local people refused to put signature in seizure list. After completion the inspection we left the spot at 2:20 PM.
