On 16.02.2018 at about 3:05 p.m. I Sri Swapan Kumar Das, AE & Station Manager, Bagmundi CCC along with 1. Sri Sukhen Mondal, DE(E) Purulia Regional Office, WBSEDCL 2. Sri Ambujaksha Pratihari, Statistical Officer, Purulia Regional Office, WBSEDCL 3. Sri Santi Kumar Majhi, HG TSH Bagmundi CCC, WBSEDCL, entered the premises of Sri Satyabrata Mahato, S/O Late Lankeswar Mahato of village Srabandih, P.S.- Bagmundih, Dist- Purulia and found Sri Satyabrata Mahato was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.12 KVA. As Sri Satyabrata Mahato, S/O- Late Lankeswar Mahato committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri.
