Sir,

In producing herewith the accused person namely Tapan Kuiry (30 year) S/O-Nemai Kuiry of Vill- Nawadih, P.S.-Baghmundi, Dist-Purulia along with seized articles 1) 13 sealed bottle of "Dilse Country Sprite", each bottle containing 600 ml of CS, 2) 2 white plastic jarican, each jarican containing approx 16 liter of I/D leiquor, 3) 14 pcs of disposable plastic glass, 4) 5 empty bottle of "Dilse Country Spirit", 5. Rs. 132/- as sale proceed which were seized under proper seizure list duly signed by the witness.

I beg to submit that today on 11.02.18 at about 19:15 hrs during the special raid I along with 1. ASI Sanjib Chatterjee, 2. C/600 Amit Shit and C/1228 Babulal Hansda arrived at Suisa market and conducted a raid in the shop of Tapan Kuiry S/O- Nemai Kuiry of Vill- Nawadih,, P.S.-Baghmundi, Dist-Purulia, the shop is styled as B.K Gift House, acting on a secret source information against illegal stock and selling of liquor of the above noted anticipated place and found the Tapan Kuiry S/O- Nemai Kuiry of Vill- Nawadih, P.S.-Baghmundi, Dist-Purulia were keeping/ selling Id Liquor (Chullu) and country spirit which were kept under his possession in his shop. Seeing the police party the customers fled away and after a small chase we were able to apprehend the seller as noted above. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he was arrested U/S- 67 B.E. Act. And also seized 1) 13 sealed bottle of "Dilse Country Sprite", each bottle containing 600 ml of CS, 2) 2 white plastic jarican, each jarican containing approx 16 liter of I/D leiquor, 3) 14 pcs of disposable plastic glass, 4) 5 empty bottle of "Dilse Country Spirit", 5. Rs. 132/- as sale proceed which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. A sample ID liquor (Chullu) taken out as sample and all seized articles were labeled properly in presences of witness and accused person. Hence I arrested the above noted person. During arrest the ground of arrest was duly notified, issued arrest memo U/S- 50 Cr.P.C and handed over a copy of the same to the arrested person.

The above noted arrested accused person namely, Tapan Kuiry S/O- Nemai Kuiry of Vill- Nawadih, P.S.-Baghmundi, Dist-Purulia committed an offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id Liquor (Chullu) and country sprit from his sole possession in his own shop.

Under the fact and circumstances therefore pray a Case U/S- 46 A(c) B.E. Act. 1909 may kindly be started against the said accused person namely Tapan Kuiry S/O-Nemai Kuiry of Vill- Nawadih,, P.S.-Baghmundi, Dist-Purulia.
