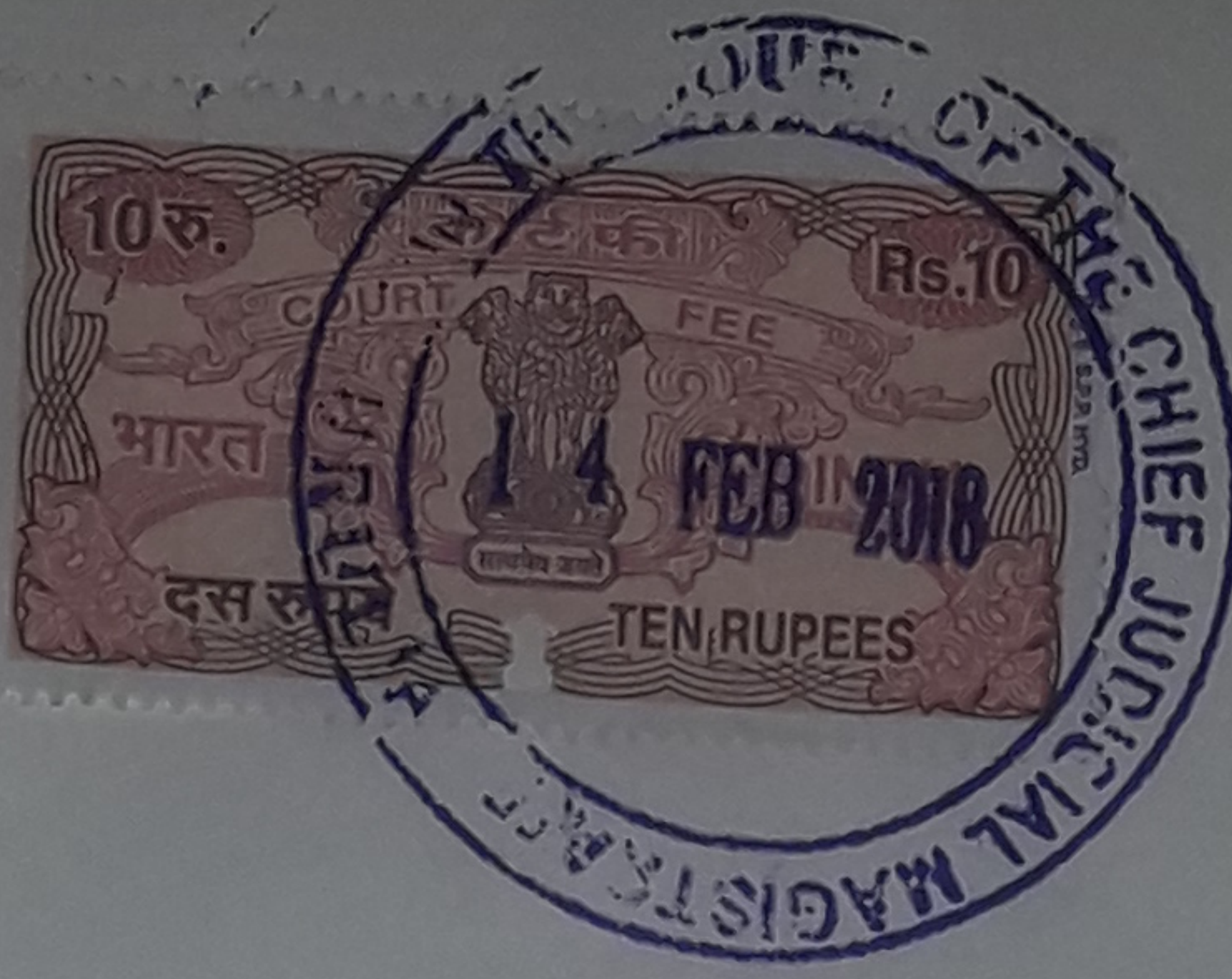

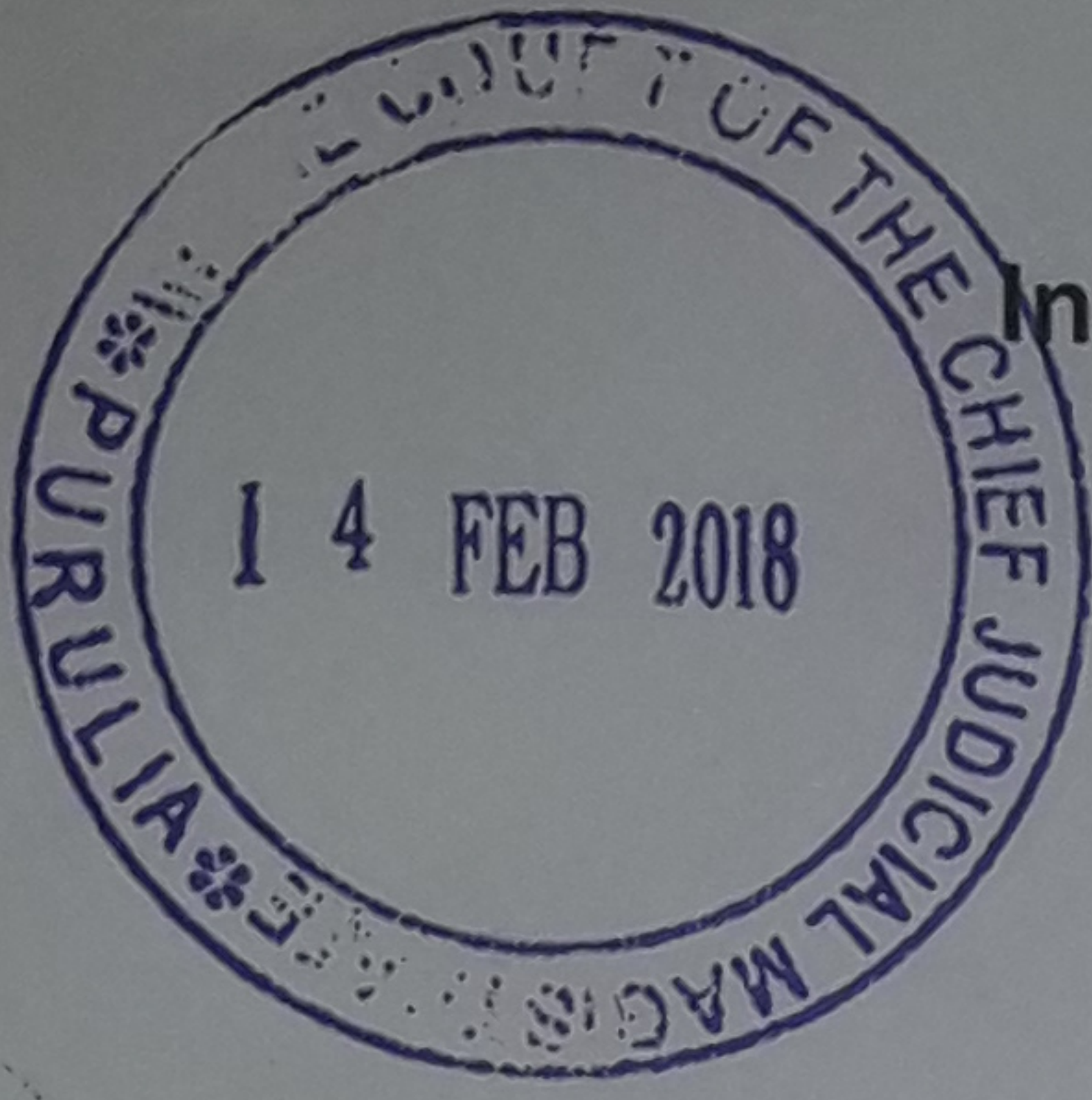

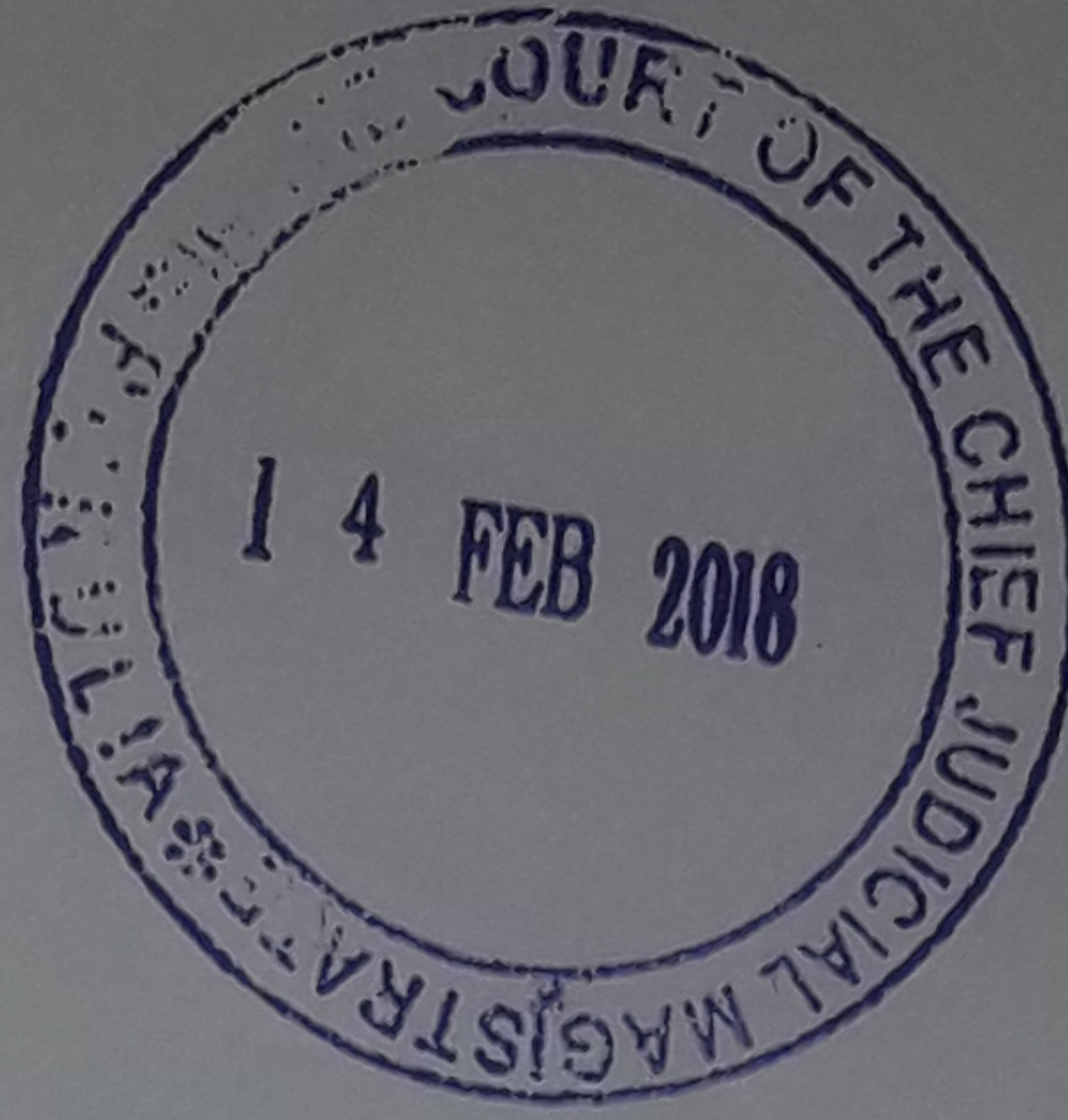

Since after few months of marriage and on 12.12.2017 at about 04: 00P.M.

F. Place of Occurrence:

At the inlaws House of the complainant at Village - Ibildih, P.O. Dhanudih,  
P.S.- Bagmundih, Dist- Purulia.

The above name complainant begs to state as follows:-

1. That your complainant and witnesses has been residing under P.S.- Barabazar and P.S. Bagmundi within Dist.- Purulia and the place of occurrence is/was under Bagmundi P.S. and within the jurisdiction of this Ld. Court.
2. That your petitioner married to one Akash Gorain, S/O Sri Mohan Gorain of village Ibildih, P.O. – Dhanudih, P.S. - Bagmundi, District – Purulia, on dated 18.06.2010 corresponding to 03<sup>rd</sup> day of Ashar 1417 B.S. as per Hindu rites, rituals and customs prevalent in their society.
3. That at the time of marriage the father of your petitioner as per demand of the acd no 1 and his family members the father of your complainant gave a sum of Rs. 50,000/- cash, one gold Ring, utensils, clothing etc. total valuation of One lakh including cash.
4. That after solemnization of marriage the acd No 1 took your petitioner to his residential house at village Ibildih, P.S. Bagmundih, District – Purulia and started to living there as husband and wife. After expiry of one month of peaceful matrimonial life the acd No 1 and his family members started to torture upon your petitioner both physical and mental demanding further dowry of Rs 30,000/- from your petitioner. But your petitioner showed his unablenss as a result the torture upon your petitioner day after day by way of non

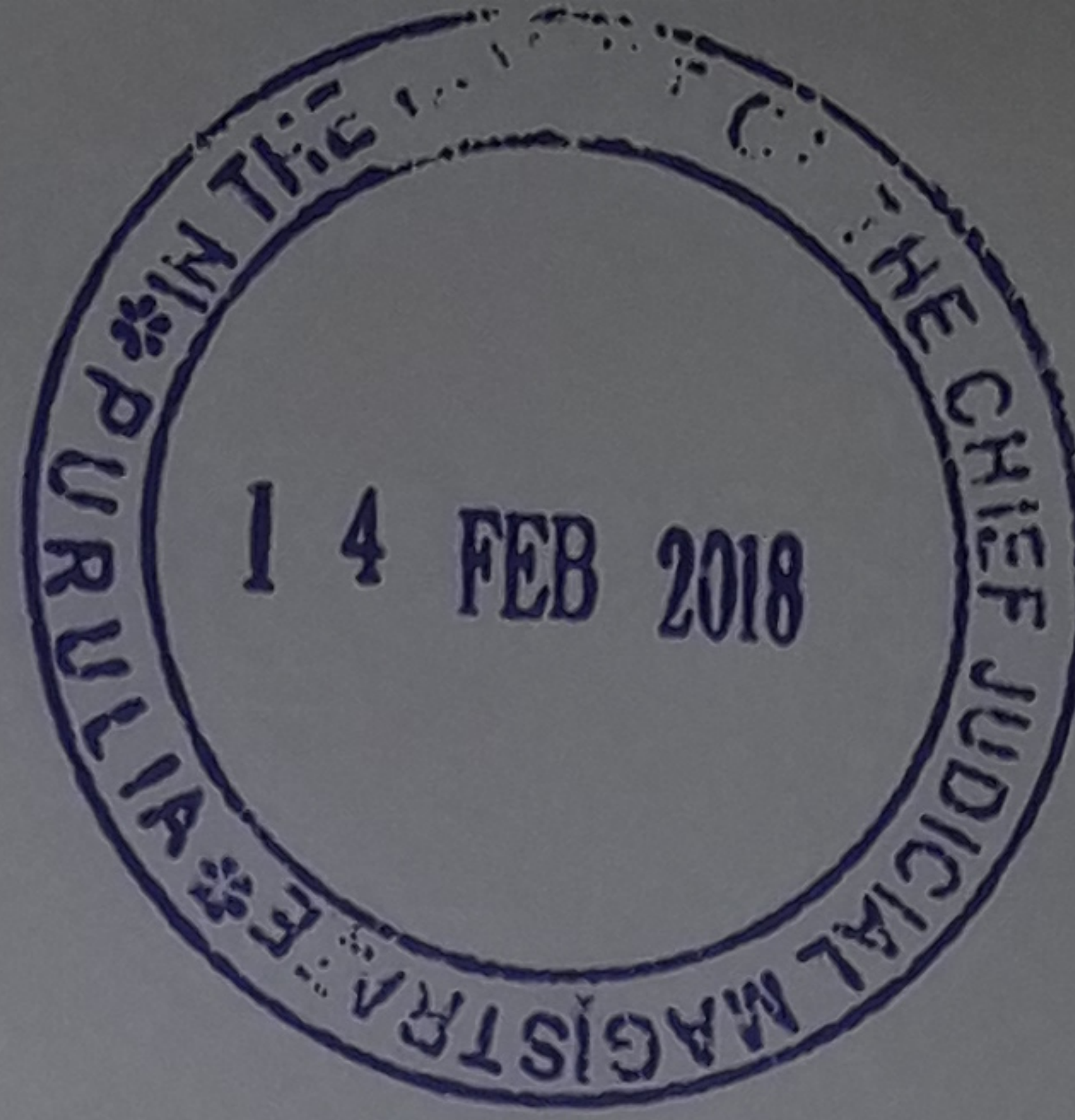

providence of fooding, and clothing not sharing bed with your petitioner compelled to remain in Chalaghar along with her minor child.

5. That lastly on 12.12.2017 at about 04:00 P. M. the husband of your petitioner Akash Gorain, mother in law Malati Gorain and father in law Mohan Gorain all of village Ibildih, P.O. Dhanudih, P.S. Bagmundi, District Purulia assaulted your petitioner with fist and blows mercilessly and tried to set fire by way of pouring Kerosene upon your petitioner and thus tried to kill your petitioner but somehow your petitioner manages to escape with her minor child at his father's house since then your petitioner is residing at her father's house at village & P.O. Bhikhari Cheliyama under P. S. Barabazar, District Purulia.
6. That your petitioner also filed a Misc. Case being no. 231/2017 under Domestic Violence Act. which is pending before the Ld. J.M. 1<sup>st</sup> Class (2<sup>nd</sup> Court), Purulia in which the next date was 19.03.2018 fix for S/R and appearance of the above named aced. persons.
7. That your complainant informed the matter before the Bagmundi P.S. for reported the incident against the above said aced. persons but due to reason better known to the police official of the Bagmundi P.S. did not take any action of the said complain. Thereafter on 18.12.2017 your complainant informed the matter to the Superintendent of Police of Purulia but till today not any action has been taken by the police of Bagmundi P.S. against the aced. persons. So your complainant takes shelter before your Honours Court.
8. That the aced. persons have committed the offences and they are liable to be punished accordingly.
