of Balarampur CCC, WBSEDCL do hereby lodge complaint against Sri Manik Das
S/o dt. Amulya Das resides at vill- Namsole (Dhatar), P.O. Namsole, P.S. Balarampur
Dist. Burdiga to the effect that received an information that the aforesaid
accused person is committing theft of electricity in his cultivating land by
way of direct hooking from the LTOH line of WBSEDCL.

Acting upon such information today on 02/02/2018 from 2.10 Pm to 2.40 Pm
I along with Sri Anup Mandal SAE, Sri Amit Kr. Hela, OE and the technical
persons of M/s. Ajoy Kr. Ghosh (Entitled Agency of WBSEDCL) inspected the
cultivating Land of Manik Das and held raid.

During raid and inspection it was detected that the Accused Manik Das
is ~~etc~~ using electricity dishonestly by making direct hooking from the
nearby LTOH line of WBSEDCL for running one Borewell Submersible
pump for watering his cultivating land having connected load of
1 HP (0.746 kW).

No notice was served to the consumer ~~has~~ as the incident occurred in
an open field and he is not a bonafied consumer.

I prepared inspection report in presence of the accused and assessed the load as 0.746 kW. Details have been mentioned in the inspection report which was duly signed by the accused.

I directed the technical persons of M/s. Ajoy Kr. Ghosh (Enlisted Agency of WBSEDCL) to disconnect the hooking line from our LTOH Line. Accordingly they disconnected the aforesaid hooking line.

I prepared seizure list in presence of the witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the accused. A copy of the seizure list was handed over to the accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135(c) (a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
