of Balarampur CCC WBSEDCL do hereby lodge complaint against Ratan Majhi
S/o Chata Majhi resides at vill- Kendradik, P.O- Kurni, Ps Balarampur
Dist- Purulia to the effect that received an information that the aforesaid accused
person is committing theft of Electricity in his residence by way of direct hooking
from the nearby LTOH line of WBSEDCL.

Acting upon such information today on 20.02.2018 from 10.00 Am to 10.30 Am.
I along with Sri Anup Mandal, SAE, Sri Amit Kr Hela OE of Balarampur CCC
and technical persons of M/s. Ajoy Kr Ghosh (entitled agency of WBSEDCL)
inspected the premises of Ratan Majhi and held raid.

During raid and inspection it was detected that accused Ratan Majhi is
using electricity dishonestly by making direct hooking from the nearby
LTOH line of WBSEDCL for running 2 Nos 100 watt Lamp & 1 No 60 watts Lamp.
having connected load of 0.26 kW.

I prepared inspection report in presence of the Accused and assessed the
load as 0.26 kW, details have been mentioned in the inspection report.
The accused refused to sign on the inspection report.

I directed the technical persons of M/s. Ajoy Kr. Shukh (entitled agency of WBSEDCL) to disconnect the hooking arrangement from our LTOH line. Accordingly they disconnected the aforesaid hooking arrangement from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list. The accused refused to sign on the seizure list. A copy of seizure list was handed over to the accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For his activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135 (i) (a) of electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
