I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, AE & Station Manager of Balarampur CCC, WBSEDCL do hereby lodge complaint against Aswini Bessa S/O Lt. Manindra Bessa resides at vill - Kendradih, P.O. Kurmi, P.S. Balarampur Dist - Purulia to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of direct hooking from the nearby LTOH line of WBSEDCL.

Acting upon such information today on 20.02.2018 from 9.15 Am to 9.50 Am I along with Sri Anup Mondal SAE, Sri Amit Kr. Hela OE Balarampur CCC and technical persons of M/s. Ajoy Kr. Shosh (Enlisted Agency of WBSEDCL) inspected the premises of Aswini Bessa and held raid.

During raid and inspection it was detected that accused Aswini Bessa is using electricity dishonestly by making direct hooking from the nearby LTOH line of WBSEDCL for running 1 no 60 watt Lamp & 1 no 20 watt CFL having connected load 0.08 kW.

I prepared inspection report in presence of the accused and assessed the load as 0.08 kW, details have been mentioned in the inspection report duly signed by the accused.

I directed the technical persons of M/s Ajoy Kr. Ghosh (enlisted agency of WBSEDCL) to disconnect the hooking arrangement from our LTOH line. Accordingly they disconnected the aforesaid hooking arrangement from LTOH line.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained signature of the accused. A copy of seizure list was handed over to the accused. The local people gathered there witnessed the incident but refused to sign on the seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offence u/s 135 (i) (a) of Electricity Act 2003 (Amended in 2007)

Kindly treat this complaint as FIR and take necessary action against the accused.
