I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, A.E & Station Manager of Balarampur CCC, WBSEDCL do hereby lodge complaint against Khetra Mohan Majhi S/O Lt. Sanu Lal Majhi, resides at vill- Kendradih, Po- Kurni, P.S. Balarampur Dist- Purulia to the effect that received an information that the aforesaid accused person is committing theft of electricity in his residence by way of direct hooking from the nearby LTOH line of WBSEDCL

Acting upon such information today on 20.02.2018 from 10.45<sup>Am</sup> to 11.30 Am I, along with Sr Anup Mandal, SAE, Sri Anit Kr. Hela, O.E Balarampur CCC and technical persons of Mr. Ajay Kr Ghosh (Enlisted Agency of WBSEDCL) inspected the premises of Khetra Mohan Majhi and held raid.

During raid and inspection it was detected that accused Khetra Mohan Majhi is using electricity dishonestly by making direct hooking from the nearby LTOH line of WBSEDCL for running 4 nos 100 watts Lamp, 1 no 60 watts Lamp and 1 no 20 watts CFL having connected load of 0.48 kW. There exists one Service Connection of WBSEDCL bearing consumer ID 201766690 stands recorded in the name of the accused which was in disconnected condition due to non payment of energy bill.

I prepared Inspection Report in presence of the representative of the accused and assessed the load as 0.48 kW. Details have been mentioned in the Inspection Report. The representative of the accused refused to sign on the Inspection Report.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and the representative of the accused refused to sign on the seizure list. A copy of the seizure list was handed over to the representative of the accused. The local people gathered there witnessed the incident but refused to sign on the Seizure List and Inspection Report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person ~~has~~ has committed offence up 135(i)(a) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
