Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act , 2003 "subsequently electricity act- 2007 , to the effect that , **DHRUBA DHARASISH SING DEB S/O NIRANJAN SING DEB had consumer ID- 242201049 and meter number- L023726 of Vill- RAJDOHA, P.S- Barabazar ,P.O- NISCHINTAPUR, P.S- Barabazar , Dist- Purulia** was enjoying electricity unauthorizedly by illegal hooking from nearest LT overhead line with the help of 2 core PVC cable and he has committed theft of electricity **U/S 135(1)/A of the electricity (Amendment act-2007)**.

On 26.02.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) AMIT SING, S.A.E.(E), BARABAZAR CCC, WBSEDCL
- (2) PRADIP SARKAR, O.E., BARABAZAR CCC, WBSEDCL

At About 02.50 P.M., entered into the premises of **DHRUBA DHARASISH SING DEB S/O NIRANJAN SING DEB of Vill- RAJDOHA, P.S- Barabazar, Dist- Purulia** and inspected his premises.

During inspection, it was found that **DHRUBA DHARASISH SING DEB S/O NIRANJAN SING DEB of Vill- RAJDOHA, P.S- Barabazar , Dis- Purulia** was enjoying electricity illegally by direct hooking from nearest LT overhead line with the help of two core PVC cable in his premises at **RAJDOHA** having connected load 0.38 KVA. He was a consumer of WBSEDCL having consumer ID- 242201049 and meter number- L023726 and his connection was being disconnected on 07.09.2017 on the consumer's request.

From the above arrangement he was using the following equipment:

01. 02 NOS ELECTRIC FAN
02. 02 No. Bulb (100 Watt)

Out of which I seized the following articles:

1. 2 core PVC cable (13 mts. Approx)
2. 01 No. Bulb (100 Watt)
3. 01 No switch board.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 03.00 p.m.

The said person has committed an offence **U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act- 2007**.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
