Sub F.I.R. against Unauthorized use of Electricity against SHAKTIPADA MAHATO S/O LT. LAXMAN MAHATO of VIII-RAIDIH, P.S- Barabazar, Dist-Purulia, U/S 135(1)/A of the electricity (Amendment act-2007)
Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003 "subsequently electricity act-2007, to the effect that SHAKTIPADA MAHATO S/O LT. LAXMAN MAHATO of Vill.- RAIDIH, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorizedly by illegal hooking from nearest LTOH line with the help of two core PVC cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 26.02.2018, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) AMIT SING, S.A.E (E), BARABAZAR CCC, WBSEDCL
- (2) PRADIP SARKAR, O.E., BARABAZAR CCC, WBSEDCL

At About 3:45 P.M., entered into the premises of SHAKTIPADA MAHATO S/O LT. LAXMAN MAHATO of Vill- RAIDIH, P.S-Barabazar, Dist- Purulia and inspected his premises at Vill.- RAIDIH, P.S Barabazar, Dist- Purulia.

During inspection, it was found that SHAKTIPADA MAHATO S/O LT. LAXMAN MAHATO of Vill- RAIDIH, P.S- Barabazar, Dist-Purulia was enjoying electricity illegally hooking from nearest LTOH line with the help of two core PVC cable in his premises at RAIDIH having connected load 0.14 KVA.

From the above arrangement he was using the following arrangements:

01. 02 no electric Bulb (60 watts each) along with a holder.

Out of which I seized the following articles:

- 01. 01 no electric Bulb (60 watts).
- 02. PVC 2 core cable (13 Mtr. App.) with a holder along with hooking device.

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 4.05 p.m.

The said person has committed an offence U/S 135(1)/A of electricity act 2003 subsequently electricity (Amendment) act-
