Most respectfully begs to states

1. That the petitioner is a citizen of India and residing at the address mentioned in the cause title of the petition.
2. That the petitioner was selected by the West Bengal Regional School Service Commission, Western Region and he was recommended for appointment by the authority of the School Service Commission and on the basis of the recommendation

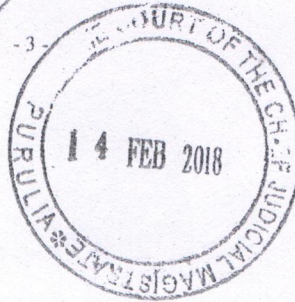

the school authority issued appointment letter to the petitioner on 08/03/2006 and the petitioner joined in the post on 13/03/ 2006 as an assistant teacher having qualification of B.Sc. (Hon.) in the subject of mathematics and the appointment at the petitioner was approved by the Additional District Inspector of the Schools (SE) Sadar Subdivision , Purulia on 06/06/2006 Vide Memo No. 779(4).

3. That your petitioner states and submits that since joining in the School the petitioner has been performing his duty most sincerely and honestly but in spite of that some of the members of the managing committee was causing harassment of the petitioner for the vested interest and in false criminal case was initiated and they got the opportunity to harass the petitioner as whenever they acquitted opportunity to meet the petitioner they would taunt the petitioner as criminal although the petitioner was acquitted from the charges by the Ld. Court.
4. That the petitioner submitted application under Right To Information Act on 17/01/2017 in connection with the financial matter of the School and the petitioner did not get any information on the basis of the application submitted before the District Magistrate concerned as the matter relation to the financial matter of the School, the teacher in- charge threatened the petitioner for initiation of criminal proceeding against the petitioner for the same.
5. That your petitioner states and submits that one of the members of the managing committee insulted the petitioner in front of the teaching staff and members of the managing committee in the meeting but it is most unfortunate that the president of the managing committee of the School and the teacher in - charge did not raise any objection for the objectionable behavior of the concerned member.
6. That your petitioner states and submits that your petitioner bound to send a letter of the Ld. Advocate requested to the authority concerned not to harass the petitioner by humiliation and/or by allotting the clerical work of the school to the petitioner for completion instead of talking classes and also not to threaten the petitioner for suspension and / or dismissal from service.
7. That your petitioner states and submits that the authority concerned ought to have considered the contents of the application under Right To Information Act. 2005 but in the instant case no response is been received by the petitioner and/or information has been furnished by the authority which is highly illegal and male fide.
8. That the school administration is not proper and transparent and in order to find out actual state of affairs of the school administration, it is necessary to cause an inquiry and to take appropriate step in accordance with law.
9. That seeing no other alternative your petitioner moved a writ application before the Hon'ble High Court, Calcutta.
10. That after receiving the notice and other information the writ the accused person became annoyed and wrongfully confined in the Canteen room of the School, Aresh majhi close up the door of the room and when the complainant started to record the picture of such offensive behavior of the said teacher, Basudev Nag one of the accused (i.e. accused no. 5) Snatched my mobile being no. 7908361893 and broken down the mobile. The above named accused persons started physical assault to your Complainant by fist and below.
11. That due to physical assault by the above named accused persons your petitioner sustained injury.
12. That your petitioner lodged complain with the O/C Hura P.S. but he refuse to accept the same . The your complainant gave a complain to the S.P. , Purulia under proper

receipt but seeing no action your petitioner sent a letter under registered post to the O/C, Hura P.S. but of no good.

13. That your petitioner filed this petition as contemplated U/S 156(3) Cr.P.C before this Ld. Court with a prayer to send the same to the O/C Hura P.S. to start a case against the wrong doer. Instigative the case unearth the wrong doer and proceed in accordance with law.
14. That the matter relates with some documentary evidences.
