Sir,

In producing here with arrested accused namely Pradip Gope Mondal (33) s/o Krishna Gope Mondal of Vill- Lalpur, PS Hura, Dist. Purulia along with seized Country Spirit bottles DIL SE (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 18.02.18 at 14.35 hrs received a credible source information I, ASI Salil Kr. Chakrabarti along with force held raid (15.05 hrs.- 15.55 hrs.) in the hotel of above noted accused person at Gorar Morh, Bhagabandh beside NH60A under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country spirit which was kept in his hotel (Maa Ambika Hotel) at Gorar Morh, Bhagabandh under Hura PS, Dist Purulia. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Then, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses & aced. person and labeled sample one bottle. Accordingly, I arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Total 24 (Twenty Four) bottles country spirit (DIL SE) have been seized measuring 600 ML each bottle and value Rs. 35 each.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E. Act may kindly be started against the arrested accused person namely Pradip Gope Mondal (33) s/o Krishna Gope Mondal of Vill- Lalpur, PS Hura, Dist. Purulia and arrange for its investigation.
