Memory Card & Pen drive etc for commercial gain, at a Mobile shops styled as " CHADNI ELECTRONICS " situated at Lalpur Bazar, P.S- Hura, Dist- Purulia owned by Amanul Rahaman Ansari (30) S/O- Ataur Rahaman Ansari of VILL- Higuli,Dol Doli P.S- Hura, Dist- Purulia detected on 20/02/2018 at Morning.

In violation of the provisions of u/s 52A the copyright Act, 1957 as amended up to date. the above downloading audio/Video songs, movies , etc for which the above unscrupulous person by such unlawful activities is earning money illegally for wrongful gain of them and causing wrongful loss to the Government and to the above music company and thus committing offences, which are punishable U/S 63/65/68A under the copyright Act.

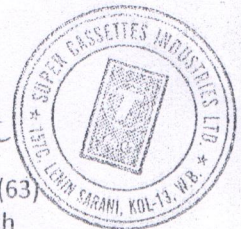
