Sir,

In Producing here with one arrested accd. Person namely Rameswar Mahato Aged 38 Yrs. S/O Nibaran Mahato of Village- Karmadih, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 01 plastic Jarcan containing approx 15 (fifteen) ltrs. Of ID liquor from his possession. I do hereby lodged this written complain to the effect that on-18/02/2018 at 16:05 hrs. I received telephonic source information that one person selling (ID liquor) at Karmadih Village. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself along with ASI Manas Kr. Panda, H.G/1634 Gopal Majhi vide C.C No. 424/18 Dtd-18/02/18 left for Karmadih village to work out the information. We reached at Karmadih village at about 18:05 Hours and held raid in the food shop of Rameswar Mahato and found that the person selling ID liquor in his food Shop. Accordingly I seized one plastic Jarcan containing approx 15 (fifteen) ltrs. Of ID liquor. under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but none is there.

Accordingly I arrested accd. Rameswar Mahato Aged 38 Yrs. S/O Nibaran Mahato of Village- Karmadih, P.S. Jhalda, Dist. Purulia, during arrest observe all the formalities regarding the guide lines of WBHRC, NHRC and hon'ble Apex court of India. On integration he confessed that he selling the said ID liquor to the villagers in lieu of money. On demand he could not produce any valid documents/license in favour of selling the same.

On return to P.S. along with accd. person and all seized articles. Put the accd. Person in the Lockup after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Rameswar Mahato Aged 38 Yrs. S/O Nibaran Mahato of Village- Karmadih, P.S. Jhalda, Dist. Purulia under proper section of law.
