Sir,

I, Gagan Baishnab, Sub-Inspector of Police of Jhalda Police station, Dist-Purulia, S/O Sachi Baisnab do hereby lodge complaint to the effect that on receipt of a telephonic information at 21:45 Hrs. regarding obstruction of West Bengal state Highway connecting road (SH-4A) from Jhalda to Gola due to a road traffic accident where one person died and one seriously injured. Myself along with officers and force namely, ASI Sk Habibul Hassan, ASI Biswajit Kalindi, ASI Mrinmay Choudhary C/1147-Bappaditya Nandi, C/380 Ajay Krishna Roy, C/ 12 Gosto Bihari Mahato vide Jhalda PS C.C No- 560/18 & 561/18 Dtd-22/02/18 respectively left PS for Dumurdih more PS-Jhalda, Dist-Purulia and evening mobile party ASI Bashudeb Acharya and his force vide Jhalda PS C.C No-559/18 Dtd-22/02/18 attached with on way to spot. After reaching the spot at about 22:25 hrs, we found that State High way -4A connecter at Dumurdih more has been blocked by the following persons having been identified by the local source and as well as local police friend at the spot namely (1) Tapan Kr Sahu S/O Lt Naresh Ch Sahu of Vill- Dumurdih (2) Nimai Mahato S/O Lt Gour Mahato of Vill Guridih (3) Fani Mahato S/O Krishnapada Mahato of Vill- Dumurdih(4) Biren Mahato S/O Lt Subhas Mahato of Vill- Guridih,(5) Dhiren Mahato S/O Lt Subhas Mahato of Vill-Guridih,(6)Sonaram Mahato S/O Malu Mahato of Vill- Guridih, (7)Jiru Mahato S/O Sukram Mahato of Vill- Dumurdih,(8) Falguni Mahato S/O Mathor Mahato of Vill- Merand(9) Brambha Mahato S/O Bhabataran Mahato of Vill- Raidih all of P.S Jhalda, Dist- Purulia and 60/70 (approx) unknown others having placed the said dead body on the midst of the Road but injured also sifted to hospital with the help of police and creating pandemonium and causing huge Traffic congestion including Ambulance, trucks and other passengers and goods vehicles making inconvenience to public. Also they were damaged by cutting the pitch road. We requested and subsequently warned several times to remove the obstruction and to regularize the traffic flow. But they disobeyed our order as knowing us police personnel also and having no pay heed our order they took dangerous way to obstruct public way. After several warnings, ultimately all the known and unknown persons among the mob who were causing obstruction, withdraw road blocked at about 00:45 Hrs on 23/2/18 and subsequently dispersed from the area and removed the dead body by police person for onward works. So they committed offence and punishable U/S-186/283/431 IPC and Read with section-18 of West Bengal High Way Act 1964. Having informed the fact to I/C Jhalda PS we returned at PS.

After arriving at PS along with officers and force at 1:35 Hrs I submitted a typed written complaint to I/C Jhalda PS to start a case against all the aforesaid persons and 60/70 (approx) unknown others as per law.
