Gulzar Ansari of village: Susnidih, P.O- Ghagra, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 12.02.2018 at about 2.35 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH, 3. Sristidhar Mahato, Sr. TSH entered the premises of Ismail Ansari, S/O- Lt. Gulzar Ansari of village: Susnidih, P.O- Ghagra P.S- Joypur, Dist- Purulia and found Ismail Ansari was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.895 KW. As Ismail Ansari, S/O- Lt. Gulzar Ansari committed theft of electric power, So, I seized the following articles after preparing the seizer list in presence of 1. Sri Ganesh Mahato, Gr1 TSH 2.
