On 21.02.2018 at about 11.40 A.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH, 03. Sri Sristidhar Mahato, Sr. TSH entered the premises of Anadi Mahato, S/O- Lt. Paban Mahato of village: Shrabampur, P.O- Pipratard, P.S- Joypur, Dist- Purulia and found Anadi Mahato was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KW.
