**The Inspector - in - Charge
Joypur Police Station**

Sir,

In producing here with arrested accused persons namely 1) Eklakh Chowdhuri@ Chhutu @ BhutChhua (30 yrs) S/o-Tahit Chowdhuri of Vill-Karkara(Sha more), PS-Joypur, Dist-Purulia, , 2) Fakruddin Ansari@ BoroChhutua @ Modna(30 yrs) S/o-Kamiruddin Chowdhuri of Vill-Dambera, PS-Joypur, Dist-Purulia and seized articles (1) one country made pipe gun length approx 22 cm with Iron butt & one round live 8 mm ammunition, (2) one iron rod, (3) One Tabla(Tangi) with wooden butt approx 3.8 foot in length, (4) one sword length approx 2.8 Ft. & (5) one iron Sabol length approx 2 ft. lodged complain against them and 04 others to the effect that on 21.02.18 at about 22.15 Hrs received a credible tip that a gang of dacoits being armed with deadly weapons like fire arms assembled in a patch of jungle near Mantard football ground in the back side of the Mantard village and they were preparing themselves for committing dacoity at Dungrigora side. This matter was informed to my I/C Baglata IC subsequently to IC Joypur PS and noted the information down to the GDE Vide Baglata IC GDE No 508 Dated 21/2/18. On getting the tip off as per kind order myself accompanied with force namely C/-542 Subodh Chandra Pain, C/-1187 Samar Kanta Maity C/-346 Saktipada Rajak , C/662 Dhananjoy Pandey and NVF/-905 Dharmendra Mahato all of Baglata IC under Joypur PS vide CC No. 270/18 dated 21/02/18 immediately proceeded to the anticipated place of assembly to work out the information and reached near Mantard Village at 23:05 Hrs leaving the Police vehicle No- WB 56J/3748 and started to proceed for the anticipated place on foot. At 23.25 Hrs reached at anticipated place laid on ambush and we noticed in a glimpse of light that 5/6 persons assembled in the beginning of the jungle by the side of village road near Mantard Footall Ground and those persons are whispering from which it was clear that they are preparing themselves to commit dacoity as it could be audible from the parlance of the assembled criminals. We cordoned them very cautiously. Then after disclosing our identity, I commanded them to surrender but they did not pay any heed and tried to flee away. We succeeded to nab in rounding up only 02 (Two) of them at 23.45 Hrs while the rest 03/04 were manage to escape despite of a hot chase after them. They disclosed their identity as mentioned above. We told them we want to searched them if necessary they can search us, but they told they are not willing to search us, then after observing all formalities I searched the above noted apprehended persons and recovered one country made pipe gun length approx 22 cm with Iron butt & one round live 8 mm ammunition from the back side waist of Eklakh Chowdhuri@ Chhutu @ BhutChhua with loaded one round live 8 mm ammunition then I unloaded gun with proper care and caution and one sword length approx 2.8 Ft. from the left side waist of accused Fakruddin Ansari@ BoroChhutua @ Modna and also searched the place of assembly with torch light and recovered one iron rod, One Tabla(Tangi) with wooden butt approx 3.8 foot in length, one iron Sabol length approx 2 ft . Then in between 23.50 hrs 21/2/18 to 00.25 Hrs on 22.02.17 from the place of assembly of the accused persons and from the possession of the above noted apprehended persons, after observing all formalities I, seized (1) one country made pipe gun length approx 22 cm with Iron butt & one round live 8 mm ammunition, (2) one iron rod, (3) One Tabla(Tangi) with wooden butt approx 3.8 foot in length, (4) one sword length approx 2.8 Ft. & (5) one iron Sabol length approx 2 ft.from the place of assembly under proper seizure list as well as label duly signed by apprehended persons and witnesses as Alamat property in c/w above case. On interrogation they confessed their guilt and they stated that they have assembled there with 04 others namely Rajababu sha,Ejhar Chowdhury,Raja and Lala Chowdhury for committing house dacoity at Dungri gora Side.I am to note here that I have to conduct search & seizure in presence of Police Witnesses as because as it was dead hour of night and it was a lonely place and I got information they assembled and making preparation for committing dacoity on gun point which might endanger of life of Public witnesses, so I restrained collecting witnesses. Under such circumstances it is reasonably believed that the above noted apprehended persons were assembled there for committing house dacoity. So, after observing all formalities I arrested those preparing arrest memo and ground of arrest duly communicated to them.

Therefore, I pray that a specific case may kindly be registered against the arrested accused persons namely 1) Eklakh Chowdhuri@ Chhutu @ BhutChhua (30 yrs) S/o-Tahit Chowdhuri of Vill-Karkara(Sha more), PS-Joypur, Dist-Purulia, , 2) fakruddin Ansari@ BoroChhutua @ Modna(30 yrs) S/o-Kamiruddin Chowdhuri of Vill-Dambera, PS-Joypur, Dist-Purulia along with 04 others namely Rajababu sha,Ejhar Chowdhury,Raja and Lala Chowdhury under proper section of law.
