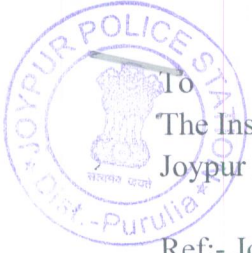

Sir,

In producing herewith two arrested accused persons namely Mihir Das (50) S/o-Lt Salabar Das & Aswani Sahis (35) S/o-Bhaktu Sahis both of Vill-Tanashi, PS-Joypur, Dist-Purulia, under arrest along with seized articles as per seizer list i.e. 55 (fifty five) pieces of plastic bottles country sprit printed as "Dil Khush" on the upper side of the bottles having 600 ML in each bottle in 03 (three) Cartoon Boxes, under proper seizure with label.

I SI Jayanta Kr. Chakarborty of Joypur PS hereby lodged a written complaint against the above noted accused persons to the effect that today (24/02/18) at about 13:05 hrs I received a credible source information that the above noted accused persons were selling country sprit illegally at Tanashi village area under this PS. On receipt such information I immediately diaries the matter at Joypur PS vide Joypur P.S GDE No- 1015 Dated- 24/02/18 and informed the matter to IC of the PS and as per his direction I along with C/-581 Tanmoy Chaterjee C/-699 Biswajit Banerjee, C/-1244 Nilkamal Bauri all of Joypur PS left to work out the information (This refers to Joypur PS CC No. 485 dated 24/02/2018). At 13:45 hrs we reached at Tanashi village side in a lonely place and my source shown the persons from a distance who were selling the liquors at there. We immediately reached there and surrounded them and found the huge quantity of country sprit "Dil Khush" bottles were kept there in "Cartoon Boxes". On searched total 55 (fifty five) pieces of country sprit "Dil Khush" bottles were found. On demand they failed to produce any license / authority of the said liquors. On interrogation they also made incoherent statement regarding possession of said liquors and told that that they were selling the same to the villagers illegally. So, finding no any other alternative way I seized the above noted articles from the possession of the accused persons and labeled, duly singed by the accused persons & witnesses in between 14:05 hrs to 14:25 hrs in which one bottle of ID liquor i.e. one 600 ML was kept as sample file with label. During interrogation they confessed their guilt as such I arrested them at 14:30 hrs & 14:35 hrs after observing all the formalities as per law issuing memo of arrest as the accused persons are liable for prosecution u/s-46A (c) of the Bengal Excise Act 1909.

I therefore pray that a specific Case may kindly be started against the accused persons namely Mihir Das (50) S/o-Lt Salabar Das & Aswani Sahis (35) S/o-Bhaktu Sahis both of Vill-Tanashi, PS-Joypur, Dist-Purulia u/s-46A (c) of the Bengal Excise Act 1909.
