Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Swapan Kr. Dey.S/o- LT. Ajit Kr. Dey, Vill+PO- Sonathali Dist-PURULIA PS- Kashipur has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003,(Amendment) Act-2007.

On dated 16.02.2018 I received a secret complain over telephone that Sri Swapan Kr. Dey.S/o- LT. Ajit Kr. Dey, Vill+PO- Sonathali Dist-PURULIA PS- Kashipur Con ID-242055743 consuming electricity by means of tapping from service cable before entering the meter.

On the basis of said complaint at about 12.50pm. I, Sri Mrinal Chowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1) Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Debraj Ray, OE Kashipur CCC.

Entered the premises of Sri Swapan Kr. Dey.S/o- LT. Ajit Kr. Dey, Vill+PO- Sonathali Dist-PURULIA and found that he is consuming electricity dishonestly by means of tapping from service cable incoming side to resist actual metering.

Total Load found approx 1.88KW ((bulb 2Nos,CFL-,5 Fan-6 refrigerator-1no, TV-1, Water Pump-1no no)

Then we disconnect his service line and seized the following articles.

- 1) Tapping point of service cable fitted with one switch board where bye passing was done.
- 2) Bulb with holder---1no

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 01.50 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
