

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Amal Hansda S/O Gopal Hansda, Vill- Jorgora, PO—Agardih Dist-PURULIA has committed theft of Electricity U/S-135(1)(a) of the Electricity Act 2003, (Amendment) Act-2007.

On date06.02.2018 I received a secret complain over telephone that Sri Amal Hansda S/O Sri Gopal Hansda, Vill- Jorgora, PO –Agardih, Dist-PURULIA consuming electricity by means of direct hooking for nearest LT pole of WBSEDCL.

On the basis of said complaint at about 02.50 pm. I, Sri MrinalChowdhury, Assistant Engineer & Station Manager Kashipur Customer Care Centre, WBSEDCL along with,

- 1)Sri Dipak Kr. Bhowmik, SAE, Kashipur CCC
- 3) Sri Sanjoy Garain, OE Kashipur CCC.

Entered the premises of Sri Amal Hansda and found that he is consuming electricity dishonestly by means of direct hooking from nearest LT network of WBSEDCL.

Total Load found approx 0.12KW (Bulb 1 Nos,CFL 2 Nos)

Then we disconnect his hooking line along and seized the following articles.

- 1) hooking device arrangement with hooking wire 23 ft (approx.)
- 2) Bulb with holder---1no

After preparation of proper seizure list The seizure list are prepared at the site and the accused person refuse to sign in the seizer list. The inspection team left the above premises at about 03.20 pm. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007 for illegal theft of electricity.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per rule.
