Bhaduri Kumar of village: Beradih, P.O- Timangda, P.S- Kotshila, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 21.02.2018 at about 12.35 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 1. Ganesh Mahato, Gr1 TSH 2. Shibaram Mahato, HG TSH, 03. Sri Sristidhar Mahato, Sr. TSH entered the premises of Ruhidas Kumar, S/O- Lt. Bhaduri Kumar of village: Beradih, P.O- Timangda, P.S- Kotshila, Dist- Purulia and found Ruhidas Kumar was enjoying electricity unauthorizedly drawing power from the nearest LTOH line of WBSEDCL through PVC wire by means direct hooking to his house premises and connected load found 0.2 KW.
