Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Jitendra Nath Murmu S/O- Parameswar Murmu of Village- Deshyardih, P.O- Pirongoria, P.S.- Mambazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 03-02-18 at about 10.35 AM, Sri Swarup Mandal, Station Manager, Mambazar Customer Care Centre, WBSEDCL along with,

entered the premises of Jitendra Nath Murmu, S/O- Parameswar Murmu of Village- Deshyardih, P.O- Pirongoria, P.S.- Mambazar, Dist - Purulia and inspected his/her premises and found that he was using electricity dishonestly by direct hooking from WBSEDCL'S LTOM System.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -

- 1) Tube light 2 (Two) nos, 90 watt each
- 2) Lamp 2 nos, 100 watt each.
- 3) Fan 1 no, 60 watt.
- 4)

out of which we seized the following -

- 1) Lamp 100 watt.
- 2) 100 ft flexible PVC wire along with hooking device.

The seizure list is prepared at the site and the accused person refused to sign in the seizure list. The inspection team left the above premises at about 10.35 AM on dated 03/02/18. The accused person has committed an offence U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R. and action may be taken as per rule.
