I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Raghunath Murmu S/O- Lt Sanatan Murmu of Village- Deshyordih, P.O- Pirangoria, P.S.- Manbazar, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 03/02/18 at about 10:20 AM, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Raghunath Murmu, S/O- Lt Sanatan Murmu of Village- Deshyordih, P.O- Pirangoria, P.S.- Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unrationally by direct hooking from WBSEDCL's LTOM System.

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
