Sir,

I do hereby lodge Complain empowered by enabling The Electricity Act - 2003 Subsequently ammended on 2007 to the effect that Deben Mudi, s/o - Dhiren Mudi of vill - Puapur, was enjoying electricity unauthorizedly from the LTOH of WBSDEL. This has Committed theft of Electricity u/s - 135 (1) (a) of the Electricity Act - 2003 ammended on - 2007.

On today (20-02-2018) at about - 13:20 Hrs J. Sibdas Ball, s/o - Dilip Karmar Ball, Station Manager, Saltore CCC alongwith ① Sri Gotionmoy Dass, SAE (E) ② Sri Kamai Sasmal, LM ③ Goulam K. Pandey, HGTSH ④ Sri Satya Rajwar, SGTSH all of Saltore CCC had been in the open field at Puapur village for inspection of LTOH line.

During inspection it has been observed that Sri Deben Mudi s/o - Dhiren Mudi at Puapur village Connected one two core Pvc Cable with the LTOH line of WBSDEL by with help of hooking device and used to run a water motor at his Brickfield illegally and unauthorizedly. This theft of Electricity u/s 135 (1) (a) detected.

From the illegal arrangement I seized :-

- ① One no water pump, Make - "V - Gaud", Single Ph, 240 volts having SL NO - BGAG 55396.
- ② Two Core Pvc Cable having length 350 feet (approx) Connected to a Switchboard having - 05 pin Socket; one no, 02 - Pin Socket one no, 02 nos Switch and having two nos hooking device at other end.
- ③ One Piece of two Core Pvc Cable having two nos two pin Plug at both end having length - 20 feet approx.

Seizure list was prepared at the site in presence of two workers of the Brickfield ① Sri Kartik Bomi s/o - Gumadhar Bomi of vill - Tiltore PS - Neturia Dist - Purulia ② Goutam Bomi s/o - Raghunath Bomi of vill - Chalmara PS - Neturia Dist - Purulia. Both the person claimed as workers of the Brickfield and put their thumb impression on the Seizure list. The accused person refused to sign and fled away from the site.

The imppection team left the premises at - 13:35 Hrs on 20/2/18

The accused person has Committed an offence u/s - 135(1)(a) of the Electricity Act - 2003 & Subsequently ammended on 2007.


You are requested to take Cognizance of the Complaint and treat it as FIR and action may be taken as per Rule.
