I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that **Atul Chandra Mahato, S/O- Late Prahlad Mahato of Village- Khudiatar, P.S.-Para, Dist- Purulia**, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.


On 02.02.2018 at about 06:35PM, I Avishek Das, SM of DUBRA PARA C.C.C, along with Mr. Sanjoy Prasad, Sr.TSH, Dubra Para CCC and Mr. Gourab Dasgupta, O.E, Dubra Para CCC inspected the premises of **Atul Chandra Mahato, S/O- Late Prahlad Mahato of Village- Khudiatar, P.S.-Para, Dist Purulia WBSEDCL**. During inspection it was found that the said **Atul Chandra Mahato** was enjoying electricity unauthorisedly by direct tapping of service cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 02 nos bulb, approx load 0.400 KW for **Commercial** purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 06:50PM.

As such **Atul Chandra Mahato, S/O- Late Prahlad Mahato of Village- Khudiatar, P.S.- Para, Dist- Purulia** has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.


