During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by hooking from the nearest LT line with hooking device

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e. one no 1 HP Pump for watering the bricks field

Out of which we seized the following: 2 core PVC cable of about 120 mts long with hooking device
