Entered the premises of Jogesh Majhi, S.O- Lakshiram Majhi of Village- Ranipur, P.O- Sanksa, P.S- Para, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by hooking from the nearest LT line

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e. one 0.5 HP pump for watering.

Out of which we seized the following: approx 60 mtr 2 core PVC cable (white color) with the hooking device and one Switch board.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 05:00 PM on dated 05.02.2018. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
