Respected Sir,

In producing herewith one arrested accd. person namely Monkhatir Rajwar (25) S/o Lt- Kalipada Rajwar of Village- Dhadkidih, PS- Para, District – Purulia with seized article i.e 19 (Nineteen) pcs sealed bottles of Country Spirit styled as “DIL Se” each Bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (23.02.2018) during my mobile duty as well as raid duty in between 19.05 hrs to 19.15 hrs acting on a tip off a raid was conducted in the kitchen room adjacent the house of Monkhatir Rajwar S/o Lt- Kalipada Rajwar of Village- Dhadkidih, PS- Para, District – Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in kitchen room. On demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 27(Twenty Seven) pcs sealed bottles of Country Spirit styled as “DIL Se” each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person.

The above noted arrested accd. namely Monkhatir Rajwar S/o Lt- Kalipada Rajwar of Village- Dhadkidih, PS- Para, District – Purulia committed offence u/s 46 A(c) B.E.Act. 1909 for unauthorized possession and sale of country spirit in his kitchen room.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Monkhatir Rajwar S/o Lt- Kalipada Rajwar of Village- Dhadkidih, PS- Para, District – Purulia and arrange for its investigation.


