Sir,

In producing herewith the arrested accused person namely 1) Madanlal (37 yrs) (driver of dumper bearing registration No JH10AH/9003) S/O- Sri Deo Nath Rabidas of Village- Ghanoodih Bafer No.- 1, P.O+P.S-Jharia, Dist- Dhanbad loaded with approx 10(Ten) MT steam coal along with seized all relevant documents in respect of the coal loaded in the dumper 04 MT from the P.O as per seizure list. Fact of the case in brief is that today i.e on 26.02.2018 myself along with C/536 Astik Bouri, and C/347 Manas kr Pathak were performing night mobile duty at Tetulhiti morh on Raghunathpur- Chandankeyari pitch road. During night mobile duty at 05.05 hrs received a credible source information that the above noted dumper bearing regn No JH10AH/9003 is standing at coal depot of Kishan Murmu near Rukni morh and the driver the dumper along with Kishan Murmu and 03/04 others are unloading coal with a view to replace the original coal. I informed the matter to O/C Para PS and as per his direction myself along with force proceeded towards the spot. When we reached to the spot i.e near to Rukni morh found the above noted dumper bearing regn No JH10AH/9003 is standing there and driver dumper noted above was unloading coal from the dumper and Kishan Murmu and 3/4 persons were standing beside the dumpers. Seeing the police party they fled away, but we could be able to intercept the driver of dumper bearing regn No JH10AH/9003. On search found that the dumper bearing registration No JH10AH/9003 loaded with approx 10 MT steam coal and approx 04 MT steam coal is on the ground which was unloaded from the said vehicle. Accordingly I seized the same. I searched the cabin of dumper bearing regn No JH10AH/9003 and seized 1) One original loading advice cum Road Challan of Bharat Coking Coal Ltd. 2) One original weightment slip of Bharat coking Coal Ltd. 3) One original Transport Challan of Bharat Coking Coal Ltd 4) On original Challan of Om Sharda Logistics Pvt Ltd, all are in respect of dumper bearing regn No JH10AH/9003. I seized all the above noted articles under proper seizure list in presence of available witnesses duly signed by them. On asked driver of dumper bearing regn No JH10AH/9003 confessed his guilt as well as from local enquiry it could be learnt that the dumper loaded with coal was to be dispatched to the authority of R.T.P.S Raghunathpur and on the way the driver of dumper bearing regn No JH10AH/9003 in connivance with the owner of the said dumper, Kishan Murmu along with 03/04 others were replacing the original coal by the cheap and lower quality coal. On this way they have been running this clandestine business. They are habituated with this type of activities. Accordingly I arrested the above noted accused person after observing all legal formalities.

Therefore I pray before you that a case may kindly be started under proper section of law against the above noted accused persons and arrange for its investigation.
