Sir,

In producing herewith the arrested accused persons namely (i) Rajesh Karmakar (27 yrs) s/o Sudhir Karmakar of Belma and ii) Janardan Bouri (35 yrs) s/o Lt. Atul Chandra Bouri of Kustaur Bouri Para both of PS- Purulia (M), Dist- Purulia and a seized black colour Hero Honda Super Splender Motorcycle bearing Reg. No WB-38S-2420, Engine No JA05EBB9D01279 and Chassis No MBLJA05E6B9D01634, I beg to lodge this complaint against both the above named arrested accused persons to the fact that, today (21.02.18) at 08:35 hrs you as O/C of the PS had received a credible source information vide Purulia (M) PS GDE No 991 Dt. 21.02.18 that the above named professional motorcycle lifters were coming towards Purulia Township from Belma village riding on a black coloured Hero Honda Super Splender motorcycle having Reg. No WB38S-2420 in order to commit theft of motorcycle at Purulia Township in the open broad day light and as per your order I with ASI Aniruddha Chatterjee, ASI Pradip Supakar, ASI Pradip Dutta, C/297 Apurba Pandey, C/1031 Pankaj Patra, JC/950 Goutam Betal & HG/1574 Swapan Mahato left for Suribandh Chharrah area on Purulia-Barakar Road along with the source to work out the information vide Purulia (M) PS GDE No 992 Dt. 21.02.18 & C.C. No 602/18. Reached Suribandh area at Mouza Chharrah on Purulia-Barakar Road around 09:45 hrs and directed the police vehicle to park it near Chharrah High School until further order. We laid on ambush behind Ails of nearby paddy land along with the source awaiting arrival of the targeted motorcycle lifter. At 10:15 hrs, a black coloured motorcycle with pillion rider could be seen coming towards Purulia side from Kustaur side and the source identified the rider driver as one Rajesh Karmakar of Belma village and his pillion rider as Janardan Bouri of Kustaur. At once, we suddenly reached the middle of the road and before the motorcyclist could take a turn to flee away towards Kustaur we cordon them. Seeing us, both the motorcycle riders started up and made an attempt to run away leaving behind the motorcycle but we at once intercepted both of them with the motorcycle before they could run away. By this time two (02) passerby coming from Chharrah side area reached that spot and being requested, both of them namely (i) Sanjit Banerjee s/o Narayan Chandra Banerjee & (ii) Bijoy Nandi s/o Lt. Sitaram Nandi both of village- Chharrah, PS- Purulia (M), Dist- Purulia, agreed to act as witnesses of seizure of the motorcycle in question. The intercepted persons on interrogation made incoherent statement in r/o their identity and about the registration certificate, Insurance certificate etc and the name of its owner. After repeated interrogation, they admitted that the motorcycle was a stolen one procured by both of them by committing theft from Gur Gali near Nilam Hotel, Purulia Town and they have fixed false and fabricated number plate on this motorcycle only on the back mudguard. They also stated that they use to tamper both the Engine and Chassis No in order to make those illegible in order to avoided identification of the original motorcycle. They also confessed before all of us including the witnesses present their that, they are professional motorcycle lifter and have stolen away many motorcycles form Purulia Township, Anara area and from many other places round a year and had sold those stolen motorcycle one after another

to different customers affixing similar fictitious number plate with factitious registration Number surreptitiously and earned a lot. They also confessed that they had assured to manufacture document in r/o the sold stolen motorcycle and handed over the purchaser shortly. They agreed that they would be able to identify the purchaser of such stolen motorcycle, their residential home and would be able to identify the stolen motorcycle each of them.

I, as such seized the black coloured Hero Honda Super Splender motorcycle, bearing Reg. No. WB-38S-2420 on the rear number plate having Engine No JA05EBB9D01279 and Chassis No MBLJA05E6B9D01634, under a seizure list prepared by me on the spot, from 11:05 hrs to 11:45 hrs in presence of those two (02) public witnesses named above under their signature as per provision of section 102 Cr.P.C. and arrested both the intercepted persons as above as disclose by them subsequently after preparing arrest Memo and Inspection Memo. I arranged to send information for intimation to the house inmate both the arrested accused persons at village Belma and Kustaur through special messenger.

I prepared label in r/o the said seized motorcycle under the signature of the witnesses including police personal and the arrested accused persons. I supplied copy of seizure list to the accused persons under their signature as mark of acknowledgement.

Since the circumstances laid to hold my view and as per believable confessional statement of both the arrested accused persons disclosed an offence punishable u/s 467/468/471/413/414/411 IPC committed by them, I pray that a specific case accordingly may kindly be started against both the arrested accused persons and to arrange its investigation.

The seizure list in duplicate and the label prepared also handed over along with the seized motorcycle for taking onwards action by the I.O.
