



#### F. Place of Occurrence:


At the house of the complainant at Village –Jamtard, within P.S.-Purulia (M) Dist- Purulia.

- 1) That your complainant and the witnesses are the resident of village Jamtard, P.S. Purulia (M) District Purulia and the accused no 2 & 3 are the resident of Village Parashibona, P.S. Hura, District Purulia, and the cause of action of this case arose when fraudulently accd. persons contracted marriage with ill motive at village Jamtard, P.S. Purulia (M), District Purulia and within the jurisdiction of this Ld. Court.
- 2) That accused Sri Bhajahari Mahato, S/O Aklu Mahato, Sri Niranjan Mahato, S /O Sasa Mahato, of village Parashibona, P.S. Hura, District Purulia brought one person at resident of your petitioner at village Jamtard, P.S. Purulia (M) district Purulia and introduced him with as Mahabir Gurjar, S/O Kutram Gurjar, of village Khera, District Kota (Rajasthan) and said that he is in search of Bride and is well acquainted to provide peristion and as you asked earlier for suitable match of your sister so we took Mahabir for negotiation for that purpose.

    Niranjan your petitioner solemnize marriage of his sister Thandi


    Mahato with said Mahabir Gurjar on 23<sup>rd</sup> Jaistha 1423 B.S.
