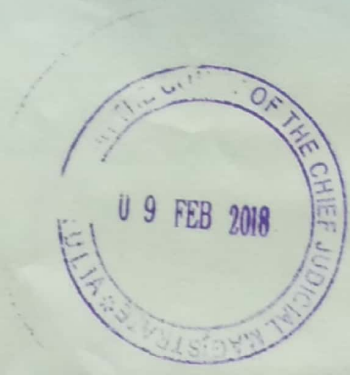
**The humble petition U/S 156 (3) of the Code of Criminal Procedure 1973 on behalf of the petitioner above named;**

Most respectfully begs to state:

1. That the petitioner is legally married wife of the accused No.1 which is still subsisting between them.
2. That at the time of the marriage, the parents of the petitioner had given about Cash Rs.40000/-, Gold ornaments, bicycle, utensils etc. at the time of marriage to meet up the demand of the accused persons.
3. That the marriage was solemnized on 5<sup>th</sup> day of Baisakh in the year 1410 at Village- Mutrudih, P.S- Purulia(M), District-Purulia.
4. That after marriage the petitioner along with these articles and ornaments was taken to her matrimonial house at of village- Sarberia, P.S.- Para, Dist.- Purulia.

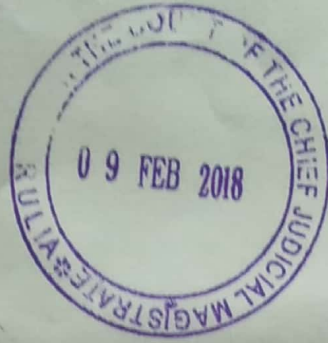

5. That the accused No. 2 is the father-in-law and accused no. 3 & 4 are the brothers –in – laws of the petitioner and accused no. 5 & 6 are the wives of accused no. 3 & 4 respectively.
6. That after marriage the petitioner and accused no.1 were peacefully residing with the other members of the family in her matrimonial house and on 09-12-2005 the petitioner gave birth to a girl child namely, Sishu Bala Das alias Shisubala Ruchi Das.
7. That soon after the petitioner gave birth to a girl child, the accused No. 1 along with other in-mates of the house, (the accused No. 2 to 6) became hostile towards Petitioner on the plea of a demand of further dowry of Rs. 50,000/- and one motor bike . The accused persons started creating consistent pressure upon the petitioner.
8. That in spite of continuous pressure the petitioner tried to convince the accused persons by saying that the petitioner is not in a position to meet more demands of the accused persons.
9. That subsequently in the year 2013 all the accused persons started inflicting mental as well as physical torture upon the petitioner and finally one day forcefully threw the petitioner and her child out of her matrimonial house. Without finding any other alternative the petitioner along with her child went to her paternal home at village- Mutrudih, P.S.- Purulia(M), Dist.- Purulia.
10. That thereafter the petitioner lodged a complaint under Domestic Violence Act and got an exparte decree for maintenance. Subsequently the accused persons convinced the petitioner to withdraw the case and brought her into the matrimonial house.
11. That, after some days the accused persons again started torturing the petitioner physically as well as mentally and again threw the petitioner and her child from their house and the petitioner finally went and started residing at her paternal house.

That, now the petitioner came to know that her husband i.e. accused no. 1 again got married on 26.1. 2018 with one Pinki Das daughter of Nimai Das, resident of village-Cheliama, P.S.- Raghunathpur, Dist.- Purulia, while the marriage of the petitioner and accused no.1 is subsisting. Sundara Das and Nimai Das the mother and father of Pinki Das respectively had helped for the second marriage of the accused no.1 knowingly.
13. That the petitioner went to Purulia (M) P.S but the police refused to take any action and also reported the matter to S.P, Purulia on 31.1.2018, but no action is taken till date.
14. That your petitioner is a female and this case requires through police probe including examination of witnesses who are residents of different places, seizure of articles, documents, etc.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia (M) P.S to treat this petition as a F. I. R. and to cause investigation in respect of the alleged incident.

And for which act of kindness, your petitioner, as in duty bound shall ever pray.
