and caught the neck of my father and saying "kill you".
My father was badly beaten and he sustained nail
scratch injuries. we two brothers and mother tried to
rescue but we also received injuries by them. Prior
to such incident son of Sukha Bauri hit my
father with bicycle but my father rebuked him. and
such all the above named persons getting assemble illegally
entered into our house and committed offences by
beating us. they left our house threatening us that
they will cut our legs if they saw us on road. My
father has been admitted to Purnia Sadar Hospital for
treatment as such delay has been caused.
Therefore please taken legal action against the persons
mentioned above as early as possible.
