Resulting this accident the left leg of Mr. Pradip Kumar Awasthi has been fractured and the third, fourth and fifth finger of his left leg has been amputated and even the motor cycle has been completely damaged.

His name has been wrongly recorded in hospital records, it is mentioned as "P.K. Ayasthi 70 yrs male" instead of P.K. Awasthi, S/O Lt. Laxmi Narain Awasthi.
