That, I come to know from the relatives
that at 10.20 hrs today Mr. Deepak Kumar
Awasthi, S/o Lt. Laxmi ^{Murti} Awasthi,
resident of Bhat Bandh, P.O & Dist-
Purulia, came out from his house
to go to Judge's Court, when he
reached at Bhat-Bandh More,
while crossing the road suddenly
a Mini Truck 407 goods carrier, being
registered No:- WB-55-3040, came
dashing from the North side hitting
two, three person and even his
motor cycle wheel bearing 410-UP-32-
AB-2363, resulting with which he
was thrown away and his motor
cycle wheel came below the left
front wheel, resulting thereby
Tata 407 goods carrier vehicle

came to halt.

Praedip Kumar Awasthi was very much conscious. The local boys picked him and brought him in to the emergency ward in Purnia Sadar Hospital.

Resulting this accident the left leg of Mr. Praedip Kumar Awasthi has been fractured and the third, fourth and fifth finger of his left hand has been amputated. And even the motor cycle has been completely damaged.

His name has been wrongly recorded in hospital records, it is mentioned as "P.K Ayatti 70 yrs male" instead of P.K Awasthi, S/o Lt Laxmi Narain Awasthi.

So, I hereby kindly request you to take proper actions against the driver and the owner of the vehicle (number mentioned above).
