P.S- Bowbazar. and also empowered by The T-SERIES, do hereby lodge the complaint that specific information has been received which has also been confirmed by market survey and enquiry that some unscrupulous persons are storing different songs, movies, etc of T-series in their computers Hard disc and selling the same to the members of public by infringing the copyright of original copyright holder T-series and transferring the same to the customer's mobile chips in lieu of money of Rs 100/- per 8 G.B. Memory Card & Pen drive etc for commercial gain, at a Mobile shops styled as "MOBILE CENTRE" situated at Super Market, Room No- " B-7, P.S-Purulia Town, Dist- Purulia, owned by Angshuman Daripa (40) S/O- Lt. Prafulla Ch Daripa of VILL-Jailkhana More, Degudy Para, Word No-8, P.S- Purulia Town, Dist- Purulia, detected on 21/02/2018 at Morning.

In violation of the provisions of u/s 52A the copyright Act, 1957 as amended up to date. the above downloading audio/Video songs, movies, etc for which the above unscrupulous person by such unlawful activities is earning money illegally for wrongful gain of them and causing wrongful loss to the Government and to the above music company and thus committing offences, which are punishable U/S 63/65/68A under the copyright Act.

You are, therefore, requested to kindly issue necessary instruction for taking prompt and suitable action in this matter.
