I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Rajendra K. Barman was enjoying electricity unauthorizedly i.e. reconnect the service line and by passing energy meter wire con. no. 24214466 and due to this reason he - has committed theft of electricity U/S 138(1)(b) of The Electricity (amendment Act-2007).
