In producing herewith one old by-cycle and arrested one person namely Md Maksud Al (137) S/o Lt Md. Maniruddin of near DVC More, Kanta Raguni, PS – Adra, Dist - Purulia and two (02) plastic bags containing in which one blue colour plastic covered packet in each bag, containing in one bag with 11 Kg 630 Gms Cannabis (Ganja) and another blue colour plastic covered packet containing with 9 Kg 600 gms Cannabis (Ganja) and six sample packets each containing with 100 gm. Cannabis (Ganja) (three sample taken from each packets) and arrested accused Md Maksud Alam (37) S/o Lt Md. Maniruddin of near DVC More, Kanta Raguni, PS – Adra, Dist - Purulia I SI Rajat Choudhary O/C Raghunathpur PS do here by lodge complaint against arrested Md Maksud Alam (37) S/o Lt Md. Maniruddin of near DVC More, Kanta Raguni, PS – Adra, Dist - Purulia to the effect that on 18.02.18 at 14:25 hrs. duty officer ASI Tapan Kr Chatterjee got an information that one person riding upon an by-cycle had been coming from Adra side with some contraband articles. The information was duly entered in PS GD Book vide Raghunathpur PS GDE No- 880 dt 18.02.18 and duty officer informed the matter to me.

After getting information at 14:35 hrs. myself along with SI Probodh Kr Mondal ASI Prasanta Kr Dutta, C/496 Prakash Ch Mahato, C/111 Samulal Tudu left PS with Govt. vehicle bearing No- WB 56C/6223 to work out the information vide Raghunathpur PS GDE No- 881 dt 18.02.18 and C.C. No. 673/18 dt 18.02.18.

At 14:45 hrs. we arrived beside Natun Sayer on Dhalai road which is started from Raghunathpur High School to Raghunathpur Bazar Para and started waiting for the above noted by-cycle standing at the north side of the said road. At 14:55 hrs. we found that one person coming from Raghunathpur High School side towards Raghunathpur Bazar Para by a by-cycle with two plastic bags one in the left side handle of the said by-cycle and another right side handle of the said by-cycle. We stopped the said person on the above noted road. But the rider of the by-cycle try to flee away leaving behind his by-cycle and bags. But we managed to detain him. Being asked he disclosed his identity as Md Maksud Alam (37) S/o Lt Md. Maniruddin of near DVC More, Kanta Raguni, PS – Adra, Dist - Purulia. On physical verification it is found that there is one plastic bag on each handle of the said by-cycle. From the odor of the content of the bag it appears to be cannabis.

I left for PS keeping the person under police guard under the charge of SI Probodh Kr Mondal. I also submit a prayer before the SDO, Raghunathpur to depute an Executive Magistrate to be present during the search at above noted place. I also submit a prayer before C.I. Kashipur presently holding the charge of C.I. Raghunathpur by a special messenger requesting him to be present during the search at above noted place. Accordingly I am waiting at PS for the arrival of Executive Magistrate and C.I. Kashipur presently holding the charge of C.I. Raghunathpur.

At 16:00 hrs. Smt. Kaleswari Kora, WBCS (Exe), DMDC, Raghunathpur (Deputed by SDO, Raghunathpur as Executive Magistrate) and Sri Rajat Kanti Pal, CI Kashipur presently holding the charge of C.I. Raghunathpur arrived at PS. After arriving there I left the PS with the Executive Magistrate and CI Kashipur presently holding the charge of C.I. Raghunathpur beside Natun Sayer on Dhalai road which is started from Raghunathpur High School to Raghunathpur Bazar Para. Then I asked the detained person in writing to search our selves. Accordingly he searched thoroughly but found nothing objectionable. He declared this in writing.

After that we asked him that we would search him and his two plastic bags. I asked him in writing whether he wanted the search to be conducted in presence of Executive Magistrate and Gazetted officer. He replied affirmatively. I informed the matter to the Executive Magistrate & CI Kashipur presently holding the charge of C.I. Raghunathpur.

Then I started searching the person and his plastic bags. During search I found that the two bags which were on the handle of the said old by-cycle were packed with Cannabis (Ganja).

During search, I send C/496 Prakash Ch. Mahato for bring a weigh machine from Raghunathpur Market. C/496 Prakash Ch. Mahato returned at the spot with one Sukumar Gorai S/o Bhikuram Gorai of Tantipara, Ward No 4, PS - Raghunathpur, Dist - Purulia with weigh machine. Then I am weighing the above noted packets. After weighing it is found that one bag (Marked as Bag 'B') is contained with 11 Kg 930 Gms Cannabis (Ganja) and other bag (Marked as Bag 'D') contained with 9 Kg 900 Gms Cannabis (Ganja). Sukumar Gorai gave a certificate regarding the result of weighing of the Cannabis (Ganja).

Then I took three samples from each bag each contained with 100 Gms Cannabis (Ganja) as sample for taking follow up action. I seized the above noted articles under proper seizure list duly signed by the witnesses and accused person. I also packed the label all the seized articles and sample.

On demand the above noted person could not produce any documents for the said Cannabis (Ganja). I arrested him. I briefed him the ground for which he was arrested. I also asked him whether he was willing to inform any one regarding his arrest. He replied negatively. I issued arrest memo. The entire search, seizure, weight, label and arrest were done in presence of Smt. Kaleswari Kora, WBCS (Exe), DMDC, Raghunathpur and Sri Rajat Kanti Pal, CI Kashipur presently holding the charge of C.I. Raghunathpur.

After arriving the PS I started a case as Suo-motu against the accused person namely Md Maksud Alam (37) S/o Lt Md. Maniruddin of near DVC More, Kanta Raguni, PS – Adra, Dist -Purulia U/S 20(b)(i)/29 NDPS Act 1985 and directed SI Bhudev Ch. Kuiry for its investigation.
