Sir,

With due respect, this is to inform you that myself **Sri Ashoke Sahababu**, Son of Late Kanchan Sahababu, of Village-Shyampur, P.O.-Deoli, P.S.-Santhaldih, District-Purulia. W.B, alongwith my other cosharers have filed the aforesaid suit **for Declaration & Permanent Injunction** against one Dipak Kumar Sarkar, Son of Late Golok Nath Sarkar, of Village-Shyampur, P.O.-Deoli, P.S.-Santhaldih, District-Purulia. W.B, and another.

That on **18/01/2018** the Ld. Civil Judge (Senior Division), Raghunathpur, in the aforesaid suit has been pleased to pass an ad-interim order of injunction in respect of the Suit Properties by restraining said Dipak Kumar Sarkar & another from interfering with the peaceful possession of ourselves (the Plaintiffs in the said Suit).

The order has been communicated to Said Dipak Kumar Sarkar & another, but since after receiving the said order, said Dipak Kumar Sarkar, trying to violate the order of the Ld. Court, by disturbing the peaceful possession of ourselves. On 31/01/2018 said Dipak Kumar Sarkar, by engaging some persons has tried to cut the embankment of the tank within the suit properties to discharge his sullage water into the tank by violating the order of the Ld. Court. We have protested the illegal activities of the said persons but Said Dipak Kumar Sarkar was very much adamant and threatened ourselves with dire consequences. But due to our active protest said Dipak Kumar Sarkar left the place with his men.

Accordingly I request you to look into the matter & take necessary steps against said Dipak Kumar Sarkar, so that he never violates the order of the Ld. Civil Judge (Senior Division) Raghunathpur. A copy of the information slip of the Ld. Court is annexed herewith for your ready reference.
