During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly  
By **HOOKING FROM THE NEAREST LT LINE** Supply i.e. U/S 135 was detected.  
From the above system he/she was using the following Electrical equipments i.e.  
ONE CEILING FAN, ONE LIGHT

Out of which we seized the following:  
APPROX. 07 MTR SINGLE CORE FLEXIBLE WIRE WITH HOOKING DEVICE.

The inspection team left the above premises at about 02:00 PM on dated 26.03.2018. The  
accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007.
