During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly By **HOOKING FROM THE NEAREST LT LINE** Supply i.e. U/S 135 was detected. From the above system he/she was using the following Electrical equipments i.e. ONE CEILING FAN, ONE LIGHT

Out of which we seized the following:
